CA18129 ITC Conference Grants GP1 Internal Call (2019/10/01 to 2020/03/31)

Deadline December 31 2019

Conditions of application:

- ITC Conference Grants will be exclusively reserved for **PH D Candidates and Early Career investigators** (up to 8 years after PhD) affiliated with an institution of an Inclusiveness Target Country participating in the Action. The list of CA18129 ITCs appears in the COST documents: Bosnia and Herzegovina, Bulgaria, Croatia, Hungary, Malta, Montenegro, Poland, Portugal, Romania, Serbia, Slovakia, Slovenia, Turkey.
- ITC Conference Grants are applicable within each Action Grant Period (GP). Conferences in the GP1 must take place between October 1 2019 and March 3 2020.
- The applicant must be listed in the official conference program and **present a poster or paper on a topic related to the Action.**
- Conference Grants only concern **non COST activities** (irrespective of the nature of conferences, seminars, workshops, etc.)
- Applicants will be requested to **submit an 350 words abstract and a short cv.**

Evaluation Criteria

- Relevance of the conference from a scientific point of view, with respect to the Action's aims – up to 6 points.
- Applicant's CV – up to 3 points.
- Promotion of gender balance in the overall selection of applicants – up to 1.5 points.
- After GP1, priority will be given to the applicants who have not enjoyed the grant before.

Deadline

- Applications for GP1 should be directed to the ITC Conference Grant Coordinator Alexandra Merle (alexandra.merle@unicaen.fr) before December 31 2019.

Financial details

According to COST rules, Conference Grants do not necessarily cover all the expenses related to participating in a given conference.

Up to a maximum of EUR 2 500 in total can be afforded to each successful applicant, including:

- travel expenses,
- accommodation and meal expenses (up to EUR 160 per day),

- conference fees (up to a maximum of EUR 500). Documentary evidence of the conference fee amount must be provided by the applicant.

When meal and accommodation expenses are supported by the hosting institution as part of the provisions offered in their conference package, the amount for subsistence afforded to each eligible participant must be deducted from the Grant.

The Grantee has 30 calendar days from the end date of the Conference to submit either a certificate of participation or a report to the ITC Conference Grant Manager of the Action, and the Action's Grant Holder.

Payment of the Grant is subject to the submitted certificate of attendance or the report being approved by the ITC Conference Grant Manager.
